DISCUSSION TOPICS

General Meeting Recap Conversation – Chairwoman Long requested any comments or discussion regarding NJGF Lightning Talks general meeting presentations from earlier in the day. Consensus among the Executive Committee regarded the earlier general meeting very successful that included smooth transitions for each of the ten presentations. It was noted that although attendance numbers were not yet verified, this general meeting may have been the highest virtually attended meeting to date. It was agreed that next time there should be a dedicated chat moderator to alert the speaker to questions submitted from the chat window.

TASK FORCE REPORTS

Geodetic Task Force Update – Office Embley reviews updates for the latest goals and mission statement with the Geodetic Task Force Chairman Eckhardt. The summary of agreed changes includes specifying the new datum 'National Spatial Reference System 2022', replace 'surveyor' with 'geospatial community'.

Elevation Task Force Update – Elevation data acquisition ongoing for northeast New Jersey. Officer Embley reviews the major changes in personnel composition of the elevation task force and ponders funding while comparing the aerial imagery acquisitions. The committee reviews the bylaws and confirms that Task Forces can be established or dissolved at the majority vote of the Executive Committee. It is posed that that the Elevation, Imagery and LiDar acquisition could become the "Remote Sensing Task Force". It is agreed that we do not have to vote on this today and that Chairwoman Long will serve as the acting Task Force Chairwoman. Officer Embley commits to drafting a mission statement & goals for next meeting. Asks the Executive Committee to email our thoughts and comments on this topic.

FUTURE GENERAL MEETINGS DISCUSSION

October General Meeting (in-person) – potential for presentations at the next meeting include Edwin B Forsythe, a presenter from Rowan University and June meeting overflow lightning talks.

FUTURE MEETING BUSINESS
