Accessibility for all: Hopeworks harnesses the power of GIS for a renewed understanding of the Pinelands

The focus was to improve access to natural places and promote their enjoyment by people with disabilities, their families and allies. Contested Land: Exploring the political and cultural conflict over mapping New Jersey's largest area of open space, Wharton State Forest

Jason Howell, Public Lands Advocate, Pinelands Preservation Alliance

Wharton State Forest is the core of the Pinelands National Reserve and the largest single open space area in New Jersey at 125,000 acres. In recent years, conservationists have been urging the State Park Service to implement a travel management map that would help to curtail damages occurring in sensitive habitats by illegal off-road vehicles. While simple, hand drawn maps had been issued by the visitor center for years, these were only intermittently enforced by land managers in the 20th century and so set up a cultural expectation of a land without rules. The proliferation of off-road vehicles in the late 20th and early

21st century created new urgency in the conservation community and advocates urged the Park Service to develop a formal travel management plan, setting up a contest between those who viewed the area as a lawless zone and those who wished to preserve the natural resources and scenic beauty that was the cause for its preservation as open space and the core of the National Reserve. In this presentation, Pinelands Preservation Alliance's public lands advocate, will show videos, photographs, and conduct a virtual tour of the area with consumer level GIS tools, weaving on the ground experience with historic aerial and satellite imagery, georeferenced to the State Forest.
